EXECUTIVE SUMMARY

At the request of the County Judge's Office, the Harris County Auditor's Office - Audit Division performed agreed upon procedures related to procurement contracts issued for the Harris County Flood Control District (FCD). The scope was to address the following objectives:

- Provide a listing of all awarded or amended contracts from the FCD with values exceeding \$50,000 and identify whether those were:
 - o related to professional services or other procurement, and
 - procured through the Harris County Purchasing Agent or the FCD.
- Selectively test to determine whether contracts awarded were subject to a formal, competitive
 procurement process in accordance with the recommendations adopted by Commissioners Court on
 April 23, 2024.

The covered period was April 23, 2024, to June 30, 2025.

BACKGROUND

HARRIS COUNTY'S PROCUREMENT PROCESS

The Harris County Purchasing Agent (Purchasing Agent) is responsible for managing the procurement of goods and services for Harris County departments in compliance with applicable laws and regulations. Key responsibilities include overseeing competitive procurement processes, facilitating evaluation of vendor proposals, awarding contracts, and ensuring transparency, fairness, and cost-effectiveness in purchasing. The Purchasing Agent also maintains vendor records, oversees conflict of interest requirements, and implements procurement policies established by the Purchasing Board.

On January 4, 2022, Commissioners Court approved the Purchasing Agent's Procurement Policy of the County. The policy states, "The Office of the County Engineering, Harris County Flood Control District, and Harris County Toll Road Authority / Harris County Toll Road Corporation also conduct RFQs and make recommendations to Commissioner Court for selection of Professional Services. Each division administers their own procedures or may request the Purchasing Office administer the RFQ process."

Due to the independent procurement of professional services by Harris County's Office of the County Engineer, Toll Road Authority, and the Flood Control District, the County lacks centralized tracking of these contracts. Tracking and recordkeeping of professional service awards are managed by each department.

FLOOD CONTROL DISTRICT

The Flood Control District is a special purpose district created in 1937 by the Texas Legislature and governed by the County Commissioners Court. It was created in response to devastating floods that struck the region in 1929 and 1935. Funding for the Flood Control District is mainly provided by property taxes, federal and state grants, cost sharing agreements, and funding set aside by Commissioners Court.

The Flood Control District independently procures its professional services greater than \$50,000, except those funded by federal dollars, which are handled by the Purchasing Agent. In response to the audit report issued on November 10, 2023, by the Harris County Auditor's Office - Audit Division, the Flood Control District developed a new Professional Services Procurement Policy, which, per Flood Control District Management, was implemented in August 2025¹. The new process was shared with the Audit Division, and it includes project specific Conflict of Interest certifications, a formal Request for Statement Qualifications process to establish a registry of prequalified firms, and a vendor evaluation and scoring process. The Audit Division plans to follow-up in approximately six months to verify that the new process was implemented.

¹ Per the audit report, the original due date for implementation of new policies and processes was August 1, 2024. Based on the requests from Flood Control District Management, the date was subsequently extended to: (i) December 10, 2024; (ii) May 1, 2025; and (iii) August 31, 2025.

RESULTS

OBJECTIVE 1: Listing of all awarded or amended contracts over \$50,000

OBSERVATION 1: Table 1 presents a summary of the number of contracts awarded or amended with a value exceeding \$50,000 during the scope period. See **Attachment A** for a detailed listing.

Note: The population for this analysis consists of agreements recorded under the Flood Control District department codes in the County's financial system (PeopleSoft). However, PeopleSoft does not have the functionality to produce detailed reports segmented by contract type or to distinguish procurements by the Purchasing Agent or a department. To address these limitations, the listing was supplemented with data from Bonfire, Request for Court Action documents, and information provided by the Purchasing Agent and the Flood Control District.

³ Other procurement for FCD includes contracts that are exempt from the competitive procurement process (e.g., utility adjustment agreements).

OBJECTIVE 2: Selective Testing of Competitive Procurement Compliance

For many of the contracts awarded, the vendor selection process took place prior to April 23, 2024. This is due to the inherent time lag between the vendor selection process and the awarding of the contract by Commissioners Court. This lag period includes time for evaluation, obtaining internal approvals for the recommended vendor, negotiating the contract terms and amount, and finalizing the contract.

Our testing population therefore included only those contracts which were awarded and for which the vendor selection process took place after April 23, 2024. In **Attachment A**, the shaded rows indicate the contracts included in the testing population.

Table 2 presents a summary of the number of contracts awarded or amended over \$50,000 and for which vendor selection occurred during April 23, 2024, to June 30, 2025. These contracts formed the basis for our testing.

A review was conducted for two distinct groups of contract awards:

- 1. Procurements processed through the Purchasing Agent on behalf of the Flood Control District.
- 2. Procurements handled directly by the Flood Control District.

The following procedures were performed for each group:

- Validated that vendor eligibility and debarment verifications were completed and documented.
- Reviewed vendor selection decisions to confirm that they were supported by documented evaluation criteria and justification for award decisions.
- Confirmed that Conflict of Interest forms were on file for all evaluation committee members and personnel involved in vendor selection decisions.

OBSERVATION 2.1: Procurements Processed Through the Purchasing Agent on behalf of the Flood Control District

From the 24 contracts processed through the Purchasing Agent, a sample of five was selected for testing. The review identified the following:

- Eligibility and debarment verifications were completed and documented.
- Vendor selection decisions were supported by documented evaluation criteria and related selection documentation, where applicable, or by alternative supporting documentation⁴ to substantiate the award decision.
- Conflicts of Interest forms were on file for all evaluation committee members and personnel responsible for making vendor selection recommendations.

⁴ The type of alternative supporting documentation required depends on the formal procurement method employed. For example, in an Invitation to Bid or Sealed Bidding process, the Bid Tabulation Sheet is used to identify the lowest responsive and responsible bidder.

OBSERVATION 2.2: Procurements Handled Directly by the Flood Control District

From the 16 contracts handled directly by the Flood Control District, a sample of six was selected for testing. The review identified the following:

- Eligibility and debarment verifications were completed and documented.
- Vendor selection decisions lacked supporting documentation, including evaluation criteria and justification for award decisions.
- Annual Conflicts of Interest forms were on file for personnel responsible for making vendor selection recommendations; however, for 4 out of 6 contracts tested the forms were not project specific as recommended in the audit report issued on November 10, 2023.

As stated in the Background section, per Flood Control District Management, a new Professional Services Procurement Policy was implemented in August 2025. The new process includes project specific Conflict of Interest certifications, a formal Request for Statement Qualifications process to establish a registry of prequalified firms, and a vendor evaluation and scoring process.

Internal Audit Standards

We conducted our engagement in accordance with the International Standards for the Professional Practice of Internal Auditing (Standards).
