The Harris County Auditor's Office Audit Division performed procedures relative to the Justice of the Peace, Precinct 2, Place 2 Judge George Risner Closeout for the 6-month period ended, December 31, 2022. Pursuant to the Harris County Road Law, Section 10, the objectives of this engagement were to determine whether:

- Physical and system(s) access were appropriately disabled for the former executive leader, and assigned assets were properly returned; and
- Change funds reconciled to the imprest balances authorized by Commissioners Court.
