The Harris County Auditor's Office - Compliance Audit Department performed procedures relative to the Harris County Tax Assessor-Collector & Voter Registrar Vehicle Taxes and Fees Audit for the three months ended May 31, 2020. As required by Local Government Code §115.002 (a) and (b), the Compliance Audit Department performed procedures relative to the monthly automobile collection reports and related records.

The objectives of this engagement were to determine whether:

- The amounts reflected on the monthly reports of vehicle taxes and fees collected were properly deposited with the Harris County Treasurer's Office.
- Voided transactions were properly approved by a supervisor.

The work performed required our staff to exercise professional judgment in completing the engagement's objectives. As the engagement's scope did not include a detailed inspection of all expenses or collections, there is a risk that fraud, errors, or omissions were not detected during this engagement. The official therefore, retains the responsibility for the accuracy and completeness of their financial records and assets, and for ensuring sufficient controls are in place to detect and prevent fraud, errors, or omissions.
