RE: Compliance review of the Agreement between Harris County (County) and Party and

Reception Center, Inc. (Operator) facilitating events at the Sylvan Beach Pavilion

Date: January 29, 2020

At the request of Commissioners' Court on November 12, 2019, Audit Services performed a compliance review of the agreement between the County and the Operator facilitating events at Sylvan Beach Pavilion for the period of July 2013 through September 2019.

The engagement's objectives were to determine whether:

- 1. Payments were made to the County in accordance with the terms of the Agreement.
- 2. The Operator is reporting complete and accurate records to the County.
- 3. The capital assets identified on the equipment list exist.

#### Overview

The original "Request For Proposal" dated March 1, 2013 listed anticipated revenue options which included a monthly lease amount or a flat or tiered commission rate based on gross sales revenue.

The executed contract dated July 17, 2013 required the Operator to pay the County a base rent of \$2,500 and 1% commission on gross rental revenue monthly. Our procedures consisted of reviewing monthly commission payments based on gross rental revenue.

Per the Agreement, the County pays for major repairs and utilities. The chart below illustrates the revenue received from the Operator and the expenses incurred by the County for July 2013 through September 2019:

#### Observations

Our review identified inconsistencies with the agreement related to venue rental charges, timeliness of commission payments, additional extended hour venue charges, cancellation fees, discounts, and commission payments not paid to the County. However, we were unable to perform a complete review of the County's capital assets at the Sylvan Beach Pavilion because the assets were not clearly tracked or identified as Operator or County owned. Based on the Operators commission payment patterns and the discrepancies identified, we could not definitively determine if all commissions received were accurate. However, we were able to identify \$1,120 that was excluded from commission payments (see Observations #3, #4 and #6). Details of our observations are noted below:

- 1. 202 of 612 (33%) customers were charged rental rates that were not in compliance with the daily rates identified in the Agreement. 12 of 612 (2%) customers were charged less than and 190 of 612 (31%) were charged more than the daily rental rate specified in the Agreement.
- 2. In accordance with the Agreement, on or before the 5<sup>th</sup> day of the month, 1% commission of the gross rental revenue of the previous month is due. Commission payments submitted to the County were late 83% of the time; an average of 27 days late.
- 3. The Agreement does not specify whether additional extended rental hours should be included in gross rental revenue. Revenue generated from the "extended hours revenue" was not consistently included in the 1% commission submitted to the County. Based on analytical procedures performed, \$957 (67%) of the commission generated from "extended hours revenue" was included. The remaining \$471 commission generated from "extended hours revenue" was not included. See Appendix A.
- 4. The Agreement does not specify whether cancellation fees for customers that canceled their events should be included in gross rental revenue. Based on analytical procedures performed, \$60 (10%) of the commission generated from "cancellation fees revenue" was included. The remaining \$514 commission generated from "cancellation fees revenue" was not included. See Appendix B.
- 5. The Agreement does not specify discounts that may be provided to customers. However, if a discount was provided or if a base facility rental fee was waived, the Operator paid 1% commission to the County on the discounted or waived amounts. See Appendix C & D.
- 6. Four of the events identified in the Operator's booking log were not listed in the Operator's financial reports. We confirmed the events occurred, which resulted in \$135 that was not included in the County's commission.



### Recommendation

Harris County Precinct 2 should collaborate with the County Attorney's Office and the Purchasing Agent's Office to ensure future agreements for the operation of Sylvan Beach Pavilion are more specific in defining revenues and commissions to be collected by the Operator and the County.


